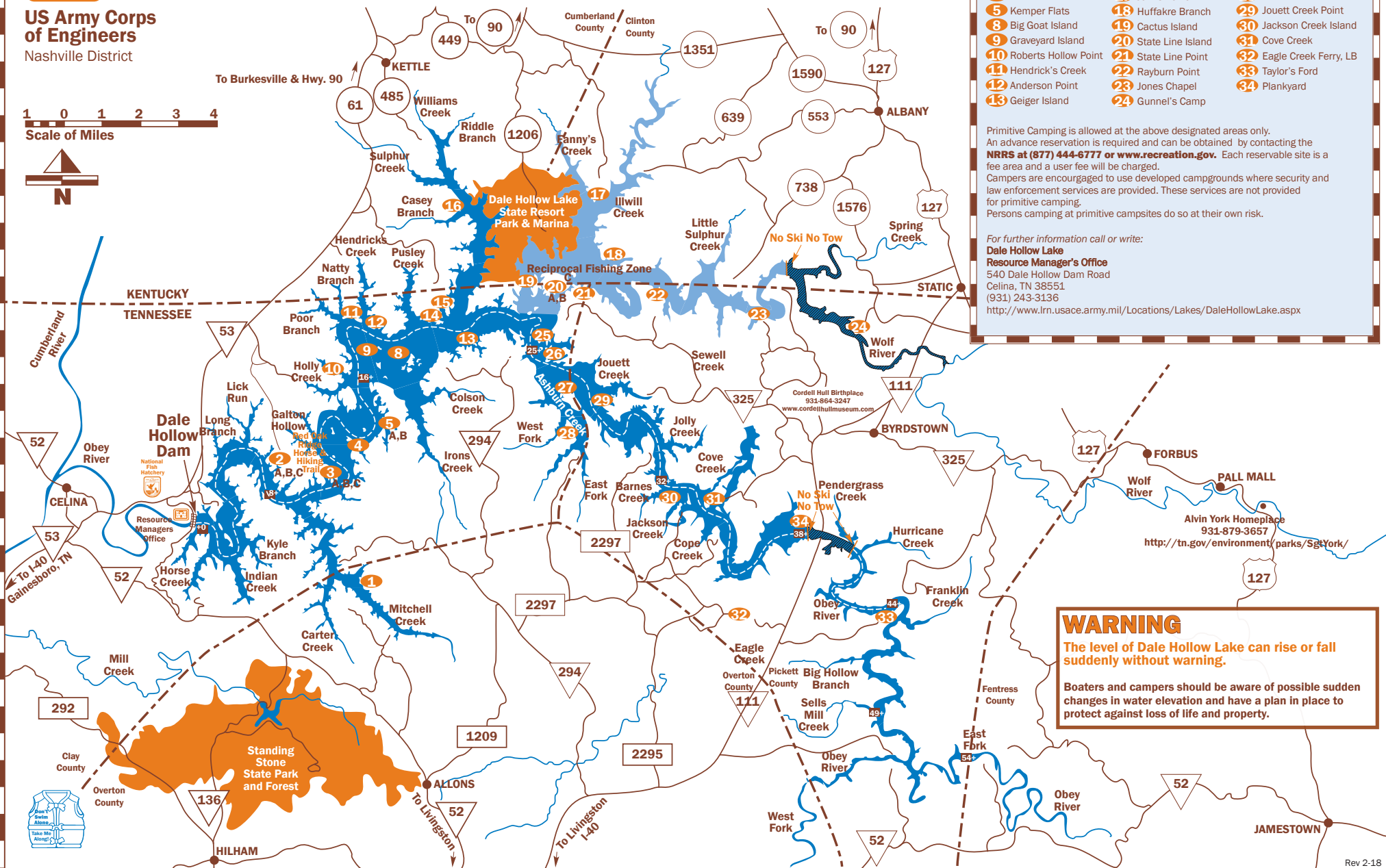

Conditions and Requirements for Dale Hollow Lake Primitive Camping

Primitive Camping on Dale Hollow offers users a unique shoreline camping experience. Note that these campsites are undeveloped; tent only, with no services. Most are accessible only by boat. Campers desiring services such as showers, flush toilets, electrical hookups, trash pickup and security should consider a developed campground. Primitive camping is permitted in designated areas only. An advance reservation is required and can be obtained by contacting the **NRRS at (877) 444-6777 or www.recreation.gov**. A use fee will be charged to offset the costs associated with participation in the reservation program. When making a reservation, query for DALE HOLLOW LAKE - PRIMITIVE CAMPING as the campground and then each specific site location is then listed by name and site number.

Public use at all Corps of Engineers projects is governed by the Rules and Regulations set forth by the Secretary of the Army to provide visitors with safe and healthful recreational opportunities while protecting and enhancing natural resources. Complete Rules and Regulations are available at the Resource Manager's Office.

Dale Hollow Lake's management policy requires all camping to be located in designated camping areas. This includes primitive shoreline camping.

- Primitive camping shall be permitted only in the locations designated.** Each primitive camper must obtain a reservation for each camping visit and have the reservation confirmation on-site while camping. An orange numbered Carsonite sign designates the primitive camping area. All camping must be contained within the designated perimeters. Certain primitive camping areas will accommodate more than one camping party. Please place your equipment accordingly to allow space for others who may also have a permit for that specific site. Post a printed copy of your confirmation letter to your tent or at the site.
 - Camping at one or more campsites is limited to 14 days during any 30-consecutive-day-period.
 - The unauthorized placement of camping equipment on a campsite without overnight occupancy for the purpose of reserving a campsite for future occupancy is prohibited. **Equipment unattended for the purpose of reserving a location will be impounded at owner's expense.**
 - The operation and parking of vehicles is restricted to approved roads, and parking areas. **Off road vehicles are prohibited.**
 - The permittee shall keep their campsite free of refuse, garbage, and trash at all times. **Upon departure, the permittee shall carry out ALL refuse, garbage, and trash, and dispose of them properly.** Cutting of trees, constructing permanent tables, hooks, or nailing into trees is strictly prohibited. Dumpsters are provided at marinas and recreation areas for disposal of garbage generated from recreational camping.
 - The spilling or discharge of pollutants or other wastes including human or animal waste, on project lands or onto project waters is prohibited. Sanitation facilities are provided at each campsite. To insure camping privileges to continue, do not deposit, discard, or place anything except toilet paper or human waste in these facilities. No hydrated lime or other additives are permitted. Air fresheners can be used to combat any bad odor occurrences.
 - All fires shall be confined to fire rings, grills, or fireplaces. Fires shall not be left unattended and must be completely extinguished prior to departure. Downed wood may be gathered for small campfires: but no standing trees, dead or alive, shall be cut for any purpose. **Chainsaws are prohibited.**
- Firewood quarantines are in effect.** Firewood from outside the area is not permitted. Only certified heat-treated firewood is allowed to be brought into Dale Hollow. For more info visit <https://www.dontmovefirewood.org>.
- The possession of firearms, ammunition, or explosive devices of any kind, including fireworks, is prohibited.**
 - Any act or conduct that interferes with, or disrupts the use of the project or impairs the safety of another person is prohibited. Individuals who are boisterous, rowdy, disorderly, or otherwise disturb the peace on project lands or waters may be requested to leave the project.
 - Compliance with all provisions of Title 36, Chapter III, Part 327, Code of Federal Regulations: the Rules and Regulations Governing Public Use of Water Resources administered by the US Army Corps of Engineers will be enforced.
 - Failure to abide by the rules is justification to issue a federal citation, appearance before the US Magistrate in Federal Court, or denial of future requests for primitive camping privileges.
 - The US Army Corps of Engineers shall not be responsible for damages to property or injury to persons which may arise or be incident to the exercise of the privilege. The reserved occupant will be responsible for taking all necessary precautions for the health and safety of the participants.
 - Since there are a limited number of designated primitive campsites on Dale Hollow Lake, houseboats should not use these sites for moorage unless the occupants are actually camping and a primitive camping reservation has been obtained for that site. Houseboats are permitted to tie up nearby the area.
 - Reserved campsites should be occupied by check-out on the day following your scheduled arrival date. If not, the reservation will be marked as a no-show and the site made available for another reservation. Please cancel any unused reservation so the site can be made available to others.
 - No water available. Toilet facility consists of vault/pit type.
 - Be aware that parking locations on the lake may charge a use fee for that area.

Your cooperation and compliance of our policies is greatly appreciated. Please help us protect and preserve Dale Hollow Lake for future generations. Enjoy your visit to Dale Hollow Lake. Your Safety - Our Priority!

Life jackets are the best insurance you can have if you're on or around the water - though unfortunately many of us don't take them seriously enough. The fact is, simply wearing a life jacket can save swimmers as well as non-swimmers who are suddenly in the water and may be unconscious, fatigued, in shock, inebriated, surprised, panicked - or all of the above.

Be sure you have the proper type of life jacket and wear it: once you're in the water, it may be too late to think about putting it on.

Note: Camping limited only to the above listed designated primitive camping areas. Campers found outside of these areas or camping without a reservation are subject to receive a citation and their equipment removed at their own expense.

* Alcohol is prohibited on Red Oak Ridge and Sewell Bend.

** Camping permits for Cove Creek will be limited to six people per site. Alcohol is prohibited.
